


Parish Plan Feedback – Data

On the 14 and 15 November 2008 **147** survey forms were handed out with **125** completed forms being returned. One form was completed on behalf of **2** individuals and one form on behalf of **4** individuals indicating responses from **129** individuals. This is reflected in the percentage results and gives a response rate of **87.75%**. One form was returned on the 30 November 2008 (15 days after the Parish Plan event) it was too late to add the information to the data, however, the comments have been added into the comment section.


The summary results for each graph are obtained by totalling the Strongly Agree/Agree and Strongly Disagree/Disagree figures to give an over all total. Other responses are indicated when they are above 10%.

NB. Due to the need to show figures in whole numbers, Excel has produced a number of graphs which show either 99% or 101%, this does not affect the overall results.


Housing Development




- **83%** of respondents agreed with this statement.




- **94%** of respondents indicated agreement with this statement.



- **67%** of respondents indicated agreement with this statement with **24%** neither agreeing nor disagreeing.




- **77%** of respondents indicated agreement with this statement with **13%** neither agreeing nor disagreeing.




- **56%** of respondents indicated agreement with this statement with **19%** neither agreeing nor disagreeing, **14%** disagreeing and **11%** no response.

Village Centre




- **69%** of respondents indicated agreement with this statement with **15%** neither agreeing nor disagreeing.

School Development




- **75%** of respondents indicated agreement with this statement with **10%** neither agreeing nor disagreeing.




- **77%** of respondents indicated agreement with this statement with **12%** neither agreeing nor disagreeing.


Youth Issues



- **62%** of respondents indicated agreement with this statement with **26%** neither agreeing nor disagreeing.




- **21%** of respondents indicated agreement with this statement with **47%** neither agreeing nor disagreeing and **28%** disagreeing.




- **84%** of respondents indicated agreement with this statement with **11%** neither agreeing nor disagreeing.




- **84%** of respondents indicated agreement with this statement.




- **75%** of respondents indicated agreement with this statement with **14%** neither agreeing nor disagreeing.

Medical Issues




- **74%** of respondents indicated agreement with this statement with **14%** neither agreeing nor disagreeing.

A Green and Pleasant Land




- **82%** of respondents indicated agreement with this statement with **10%** neither agreeing nor disagreeing.




- **67%** of respondents indicated agreement with this statement with **28%** neither agreeing nor disagreeing.


Promote Haughton to the wider world



- **70%** of respondents indicated agreement with this statement with **22%** neither agreeing nor disagreeing.




- **82%** of respondents indicated agreement with this statement with **12%** neither agreeing nor disagreeing.




- **65%** of respondents indicated agreement with this statement with **22%** neither agreeing nor disagreeing.


House Keeping



- **18%** of respondents indicated agreement with this statement with **15%** neither agreeing nor disagreeing and **62%** disagreed.




- **73%** of respondents indicated agreement with this statement with **19%** neither agreeing nor disagreeing.




- **31%** of respondents indicated agreement with this statement with **29%** neither agreeing nor disagreeing and **36%** disagreed.




- **25%** of respondents indicated agreement with this statement with **16%** neither agreeing nor disagreeing and **56%** disagreed.




- **43%** of respondents indicated agreement with this statement with **31%** neither agreeing nor disagreeing and **22%** disagreed.

- **28%** of respondents indicated agreement with this statement with **26%** neither agreeing nor disagreeing and **43%** disagreeing.




- **7%** of respondents indicated agreement with this statement with **48%** neither agreeing nor disagreeing and **41%** disagreeing.

What have we missed comments

Response No.	Section	Comment
1		Seems a good all round package
5	Housekeeping	Speed signs no longer have effect.
5	Other	Condition of lanes from village to White Cross and speed of traffic down lane.
6	Other	The people of White Cross feel neglected by the Highways Department - cleaning and maintaining ditches, keeping roads clear from mud and horns being blown around corners instead of keeping to speed limit.
10	Other	Are you aware that Snipe are in the fields behind Moathouse Drive. Survey undertaken in 2004 - could not see any evidence of Haughton being mentioned.
13	Other	Grocery shop front spoils look of the village.
14	Other	Where can we make comments about tasks-problems-bodies involved? Does the village need further housing development? Who and when will buy the properties and will the present infrastructure cope?
15	Housekeeping	Are you implying Haughton has sufficient bus shelters?
16	Medical	Doctors surgery one day per week.
17	Other	Members of the Parish Plan Steering Group are to be congratulated and thanked on the high quality of the work.
18	Housekeeping	Parking around Haughton garage is a major safety issue.
19	Housing	Any future building should cater for more bungalows.
30	Other	Some of what you suggest already exists i.e. noticeboards. I chose to live in Haughton after I retired because of what the village already has.
31	Recreation	In allocating land for various usage the following would be my priority, An area of woodland similar in size and style to Duddas Wood in Derrington. This would provide an area for adult exercise and dog walking. It would help to offset the carbon footprint of the recent warehousing (last 10 years) and any new development. An area similar to Derrington Green is needed for the less ambulant. Sheltered housing for the over 60s. Complete the cycle way to Gnosall.
33	Housekeeping	We have been very pleased that the footpaths in Hawthorne Close have been cleared of weeds, please could we have a new road surface, it is diabolical particularly at the far end. Thank you in anticipation.
34	Housekeeping	The state of Station Road and footpaths in Hawthorne close require urgent attention. Drivers are not aware of the dangers of speeding down Station Road where pedestrians walk to the Greenway.
38	Youth Issues	If there is a problem with over subscription at the school perhaps the catchment area needs to be looked at.

Response No.	Section	Comment
38	Housing	If houses were built at Haughton Farm it would balance the village with Moathouse side rather than stretching the village away from the centre.
40	Housekeeping	Parking near the garage is a problem when turning off the main road. Cars-vans parking just off the main road has become dangerous.
42	Housekeeping	Parking by the garage (lack of footpath) is dangerous for pedestrians.
56	Housekeeping	Haughton has a big problem with speeding vehicles at the Stafford end of the village.
58	Housekeeping	Could the post office stores be persuaded to remove the ugly disfiguring blue fascia from the frontage.
61	Recreation	I may have missed this but is there any area for dog walking in the plans?
61	Housekeeping	The newly developed post office with its ghastly blue frontage is hardly in keeping with how I would like to see the shop area. The butchers is a much more traditional and is very pleasant to look at. The whole area around the shops is messy and tacky a bit like the new houses at the side of it.
62	School Issues	Why expand a school which encourages extra out of village traffic and whose nursery unit has destroyed the Mother and Toddler group and Playgroup.
68	Youth Issues	Don't forget the Play Group.
73	Housing	Communication by Parish Council-Borough Council - how big is the village/population.
75	Housekeeping	You do not mention the lack of pavement outside the garage, this is especially dangerous for pedestrians and vehicles leaving Brazenhill Lane - and when the garage owner parks cars on the front the danger becomes extreme. Also the slightest rain causes a flood at this point forcing pedestrians into the road. Another major problem is the illegal parking of cars on pavements which forces pedestrians into the road as far as I know no one has made any attempt to deal with this problem.
78	Housekeeping	The A518 weight restriction will be unworkable.
85	Recreation	Increased recreation at the village hall e.g. bowling green at the back.
91	Other	Very much appreciate all the hard work which has gone into this presentation.
92	Housekeeping Youth Issues	How can we change the frontage of the post office/village store? It looks an eyesore and is out of keeping with the village. The garage is an accident waiting to happen. If you have young children in pushchairs and also toddlers you have to go into the road, this will end in serious injury or death to a child if this situation is not changed.
94	Green Pleasant Lane	Love to see the trees and shrubs in front of the shops again.

Response No.	Section	Comment
95	Youth and Village centre	I don't see the point in developing the school, playground and general village facilities without agreeing a reduction in the quantity of houses. Surely improving these facilities only makes Haughton more desirable to developers, they and the land owners will be the only real winners.
98	Recreation	Please when you speak of village remember we are in a Parish. Please support a cycle path from village to Gnosall.
99	Housekeeping	Missing trees and shrubs in front of village shops, which would disguise the eyesore at the grocery store/post office which so many are opposed to.
102	Housing	As long as the houses to be built are not going to like the new ones by the shops as they are awful.
104	Housing Housekeeping	The land trust is a good idea, especially for the future balance of development. Good housing or no housing. Housing in keeping with the village to keep a village. Don't want the village to join up with Stafford or any other village by development. Speed and large traffic is a problem, why can't we have speed cameras at least they would create revenue.
111	Recreation	Would like also somewhere to exercise dogs as currently I have to drive elsewhere to let them off lead, to train and exercise.
113	Housing	Main requirement affordable housing for young people who wish to stay in village.
116	Housing	Affordable housing for young families and the ability to down size when needed. Apartments like town houses which are built on A518 are more appropriate to towns and cities and not rural communities.
119	Recreation Housekeeping Youth Issues	More consideration for the elderly. More seating around village. Phoenix Club for the elderly. More bus shelters. Bus stop opposite the shops should be moved towards the village hall with a lay-by and shelter. What about a scouts or guides group instead of a youth club. By developing the land to the north of Meadow Lane/Moathouse Drive will increase traffic through the estate and also down Brazenhill Lane when children are transported to the school.
121	Housing Youth Issues Recreation Village Centre	If houses are developed to the south of the village how will access be achieved other than entering/leaving via Church Eaton lane, which is narrow, Park Lane, which also narrow or someone selling part of their garden for access. The village does need a feature in the centre rather than the existing car park area. Houses are needed for people to down size into, rather than bungalows, which can be expensive. The area of parkland would be nice if this could be achieved - it would bring the playing field more into the village centre and be a facility for all to use. The football pitch does not need re-developing it has not been used for years and when it was used it was only used once a fortnight for "home games" and then only during the football season.
125	Recreation Housing	Right of way along Park Lane to Church Eaton road should be re-established for walkers. Development to the south of the A518 would require access via Park Lane, which is completely impractical due to width, levels and junction with A518.

late comment	Housekeeping Recreation	I live on the main road and the traffic problem is an abomination. The volume, weight and speed of the vehicles is almost a 24 hour, 7 days a week nightmare, and is only set to get worse with new housing and the soon-to-open freight distribution centre in Telford. The existing 30 mph and "solar speed" flash signs have very limited usefulness and I feel that speed cameras and a weight restriction on HGV's is paramount (preferably before my house is shaken to pieces!!) A weight restriction would also be beneficial on Station Road, as vehicles have a better road in Woodhouse Lane. A bowling green would benefit all ages (in centre of village).
